4. FIRST-AID MEASURES

4.1. Description of necessary first aid measures

Ingestion: Rinse mouth with water.

5. FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

Water spray, carbon dioxide, dry chemical powder or appropriate foam.

6. ACCIDENTAL RELEASE MEASURES

6.1. Personal precautions, protective equipment and emergency procedures

Evacuate surrounding areas. Ensure adequate ventilation. Keep unnecessary and unprotected personnel from entering. Do not breathe vapor/spray. Avoid contact with skin and eyes. Information regarding personal protective measures: see section 8.

To avoid possible contamination of the environment, do not discharge into any drains, surface waters or groundwaters.

6.3. Methods and materials for containment and cleaning up

Cover with an inert, inorganic, non-combustible absorbent material (e.g. dry-lime, sand, soda ash). Place in covered containers using non-sparking tools and transport outdoors. Avoid open flames or sources of ignition (e.g. pilot lights on gas hot water heater). Ventilate area and wash spill site after material pickup is complete.
