

4. FIRST-AID MEASURES

5. FIRE-FIGHTING MEASURES

6.3. Methods and materials for containment and cleaning up

Cover with an inert, inorganic, non-combustible absorbent material (e.g. dry-lime, sand, soda ash). Place in covered containers using non-sparking tools and transport outdoors.
