5. FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

Water spray, carbon dioxide, dry chemical powder or appropriate foam.

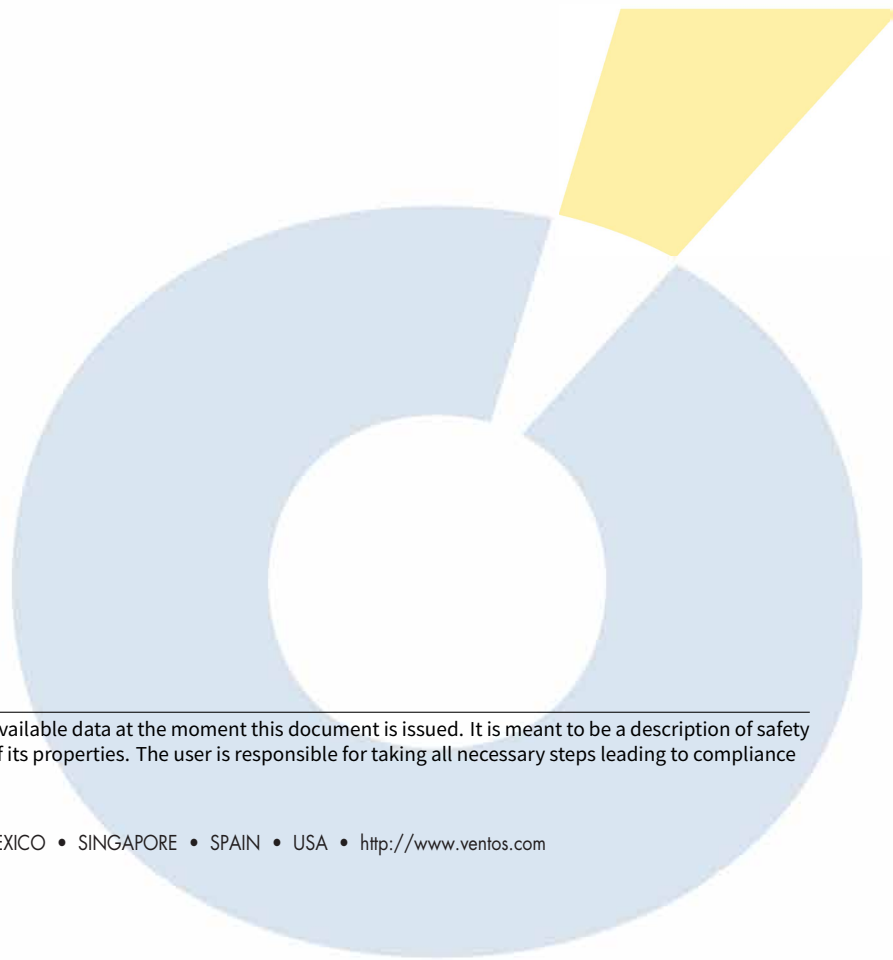
