## 4. FIRST-AID MEASURES

Ventilate area and wash spill site after material pickup is complete.

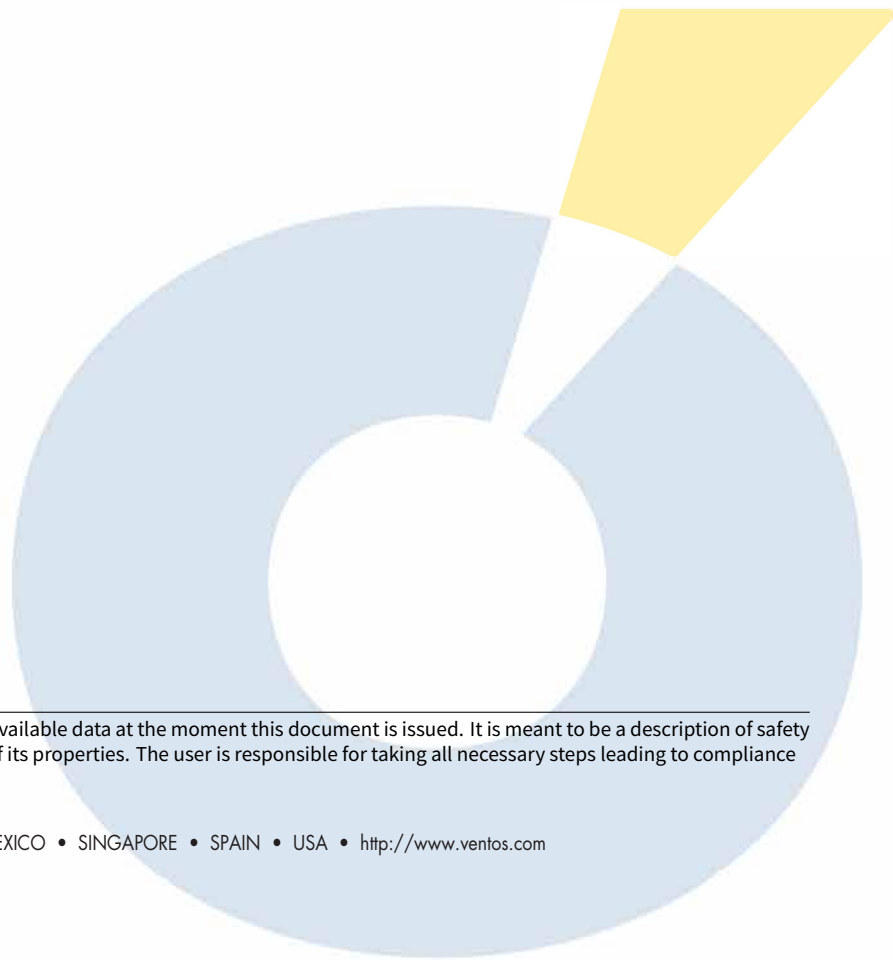
