**5. FIRE-FIGHTING MEASURES**

**5.1. Extinguishing Media**

Water spray, carbon dioxide, dry chemical powder or appropriate foam.

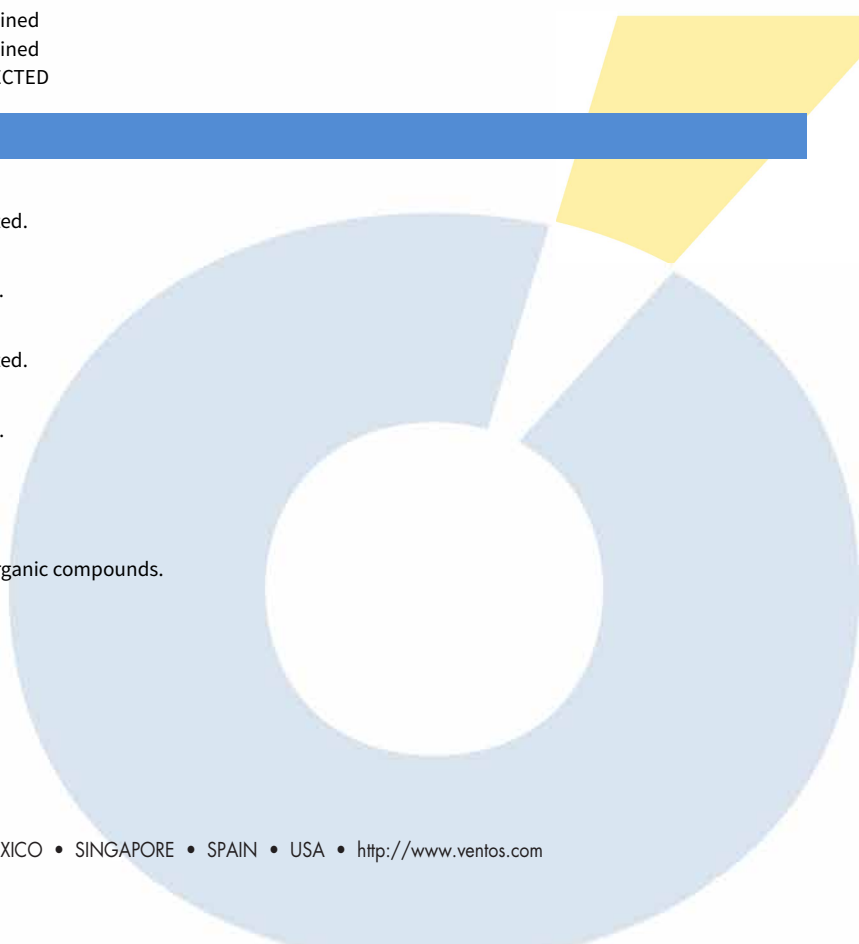

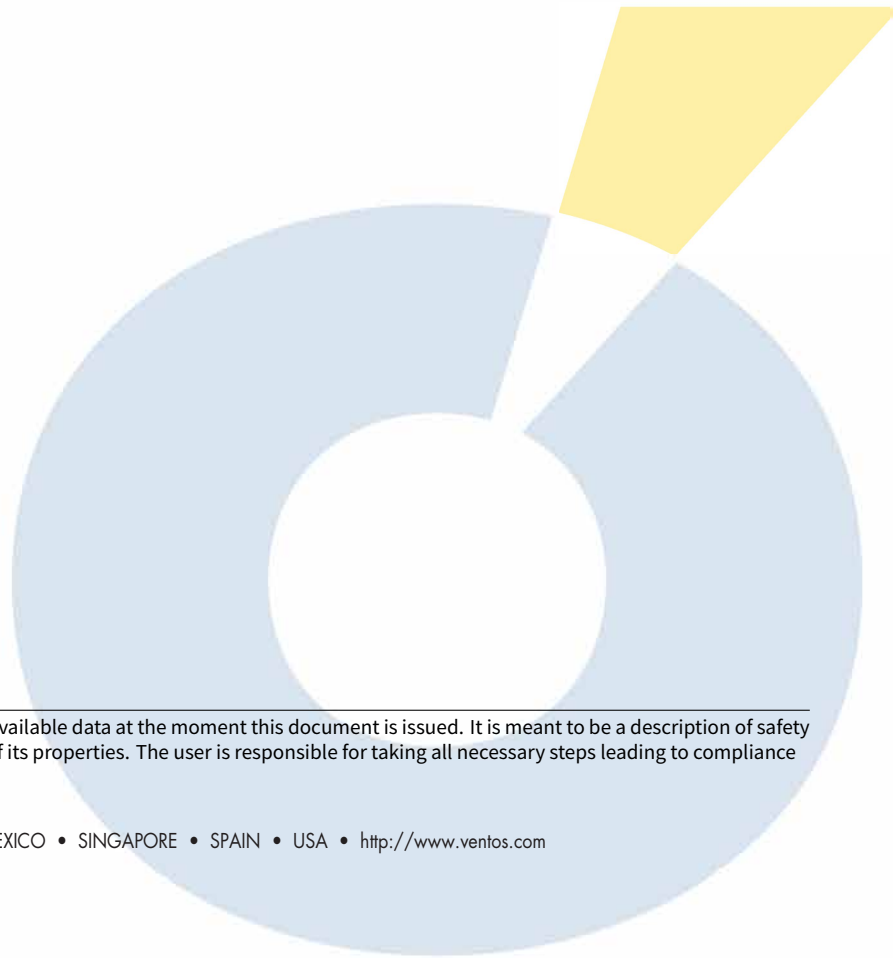
