4. FIRST-AID MEASURES

4.1. Description of necessary first aid measures

Ingestion:	Rinse mouth with water. Obtain medical advice. Keep at rest. Do not induce vomiting.
Eye contact:	In case of contact with eyes, rinse immediately with plenty of water for at least 15 minutes and seek medical advice.

5.1. Extinguishing Media
