4. FIRST-AID MEASURES

4.1. Description of necessary first aid measures

Ingestion:	Rinse mouth with water. Obtain medical advice. Keep at rest. Do not induce vomiting.

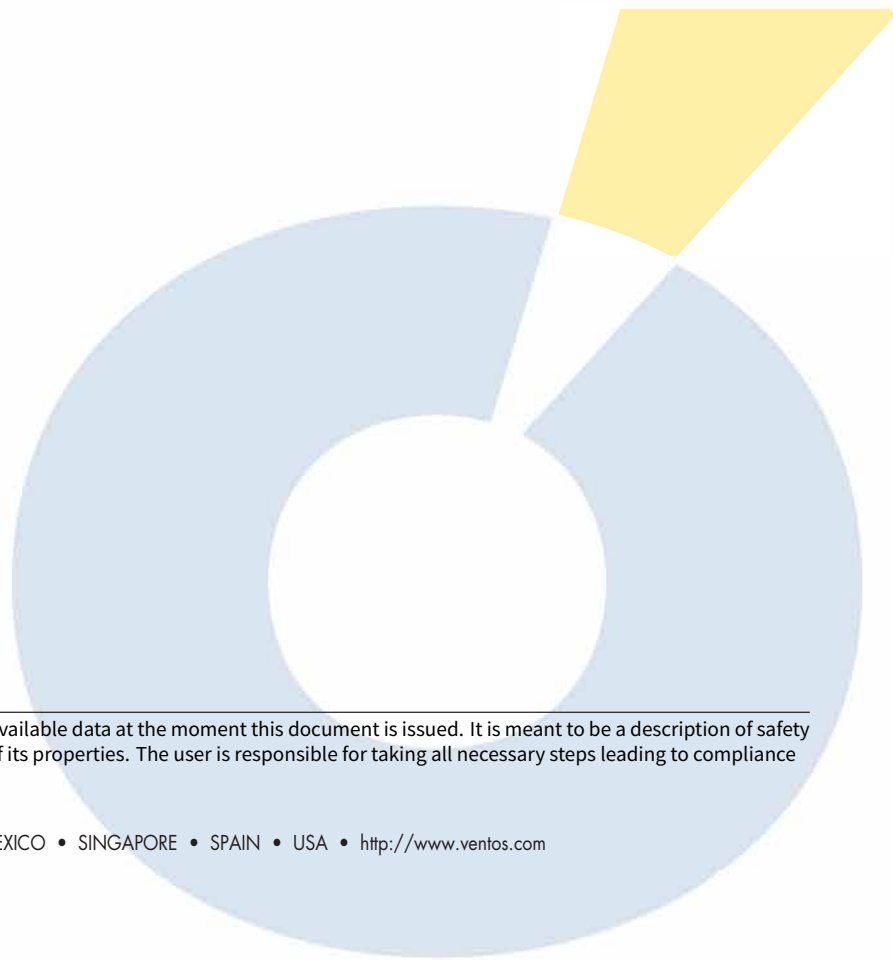
