**6.3. Methods and materials for containment and cleaning up**

Cover with an inert, inorganic, non-combustible absorbent material (e.g. dry-lime, sand, soda ash).

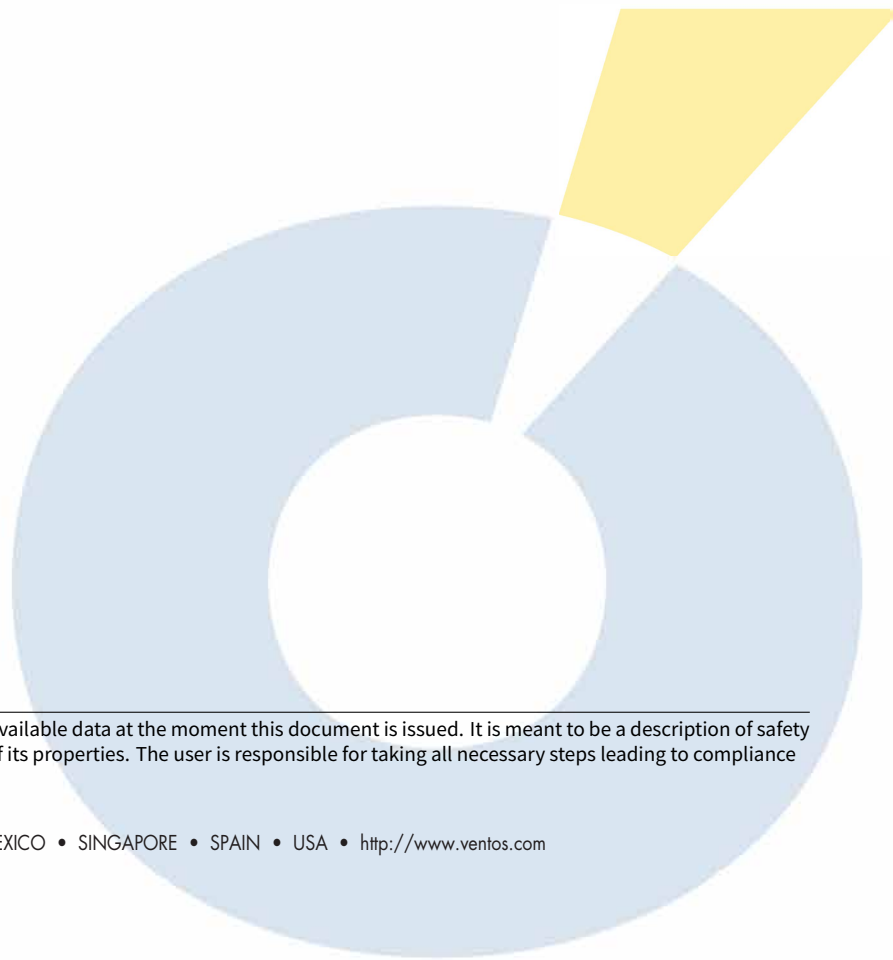
