5. FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

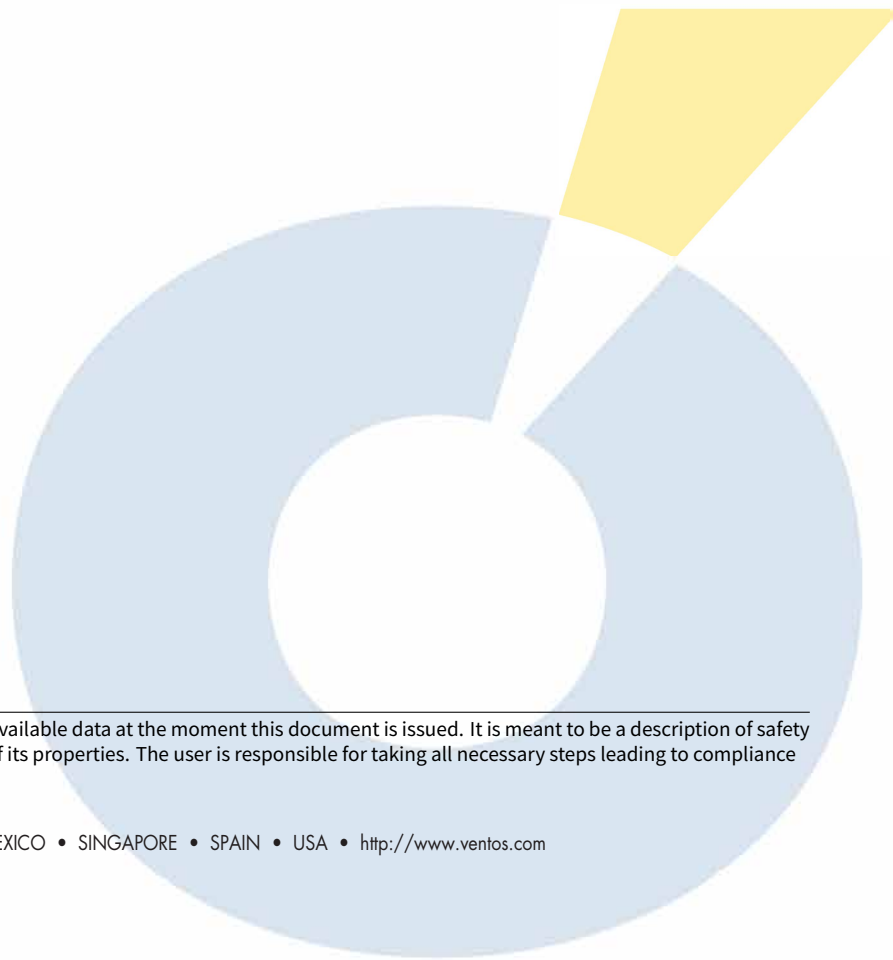
